# **Bike Lanes**

Department of Public Safety (DPS) is excited to announce the addition of bike lanes around campus! Bike lanes provide cyclists a dedicated area to safely ride and provide warning to motorists to remain vigilant of cyclists.

*There are four (4) primary notations to watch for with bike lanes:* 

Solid white line(s) on the right hand side of the motorist lane with a bike painted between the lines indicates a bike only lane.



Solid white line(s) fades to white hash lines indicates the bike lane is merging into a shared lane, where motorists and cyclists share the roadway.

#### REPORTING CRIMES ON CAMPUS

All victims of crime are encouraged to report such incidents to the police. Whether the crime occurred on SIU Campus or within the City of Carbondale, there are resources available to you. The more quickly a crime is reported, the sooner police can intervene, catch an offender, and stop the potential victimization of others. If you do not wish to pursue criminal charges, you are encouraged to speak with any member of the faculty or staff, who are trained to assist you in filing a report with the university. Whether or not you choose to file a report with Law Enforcement, the University will offer a variety of options for assistance to you and will work to address any factors which may have led to this crime.

#### Report an incident to the University:

Reporting to the University provides you with the option of addressing the incident under several University policies to include, but not limited, to Sexual Harassment, Workplace Violence, and the Sexual Assault, Dating Violence, Domestic Violence and Stalking Policy. Incidents reported to the University are investigated in accordance with the Discrimination (including sexual harassment) Complaint and Investigation procedures.

A report to the University allows for the initiation of interim protective measures such as academic accommodations, changes to housing, and changes to class or work schedules. The list below provides the ways in which a report can be made to the University.

#### **Campus Security Authorities**

Employees who have knowledge of a crime that occurred on campus or a victim of a gender-based crime are required to report this information via an <u>SIU Campus Crime</u> Report.

# **Community Resource Officer**

The SIU Department of Public Safety has a proactive, community-oriented and community-involved policing philosophy. University Housing and DPS continue to collaborate and coordinate services to resolve community issues impacting the safety and security of University Housing student residents, guests and staff. This

cooperative effort is intended to improve the overall quality of life across University Housing residence halls, programming spaces and dining facilities. Together, the Department of Public Safety and University Housing have dedicated one police officer to University Housing facilities. This officer, known as a community resource officer (CRO), provides an open and ongoing channel of communication between the various University Housing communities and the Department of Public Safety.
