

SAFETY ONLINE

The Internet was built for sharing, not for anonymity or security. Be familiar with each website's privacy and security settings. There are billions of people online but, how many of them do you want to know where you live, where you work, or who your family and friends are. You can try and maintain a degree of privacy, but ultimately what you do online is similar to what you do in public like driving in your car or walking through campus. Below are some tips for staying safe online:

- \Rightarrow Do not to post anything you would not be comfortable explaining in the future.
- ⇒ Keep personal and work/organization/department accounts separate. Use separate email addresses, phone numbers, and devices, if possible.
- ⇒ Don't accept friend requests from strangers. When available, use features that limit who may send a friend request or see your profile.
- ⇒ Use two-factor authentication whenever possible.
- ⇒ Don't post your travel plans where people who want to find you (e.g. stalkers) or people who want to avoid you (e.g. burglars) will see them.
- ⇒ Don't identify where you work on a personal account: your friends and family already know, and strangers don't need to know.

Credit Card Fraud

With the holiday season fast approaching, people are shopping for those perfect gifts for all of the loved ones in our lives. As technology advances and changes, not only do shoppers tend to utilize online shopping more, but thieves are finding easier ways to steal your credit and debit card information.

As an informed credit or debit card holder, always be alert for skimming devices that may be placed on gas pumps, ATMS, and other loca-



tions where you swipe your card. A skimming device is a detachable card reader that may be difficult to distinguish between the actual card reader. Once a consumer or cardholder places their credit or debit card inside of the skimming device, their personal banking information, credit/debit card information, and PIN number becomes compromised. This means that the thief may have all of that information and will utilize it for his or her fraudulent purposes. When utilizing any type of card reader, look for signs of tampering on the machine including, but not limited to, glue or scuff marks near the card reader or where a user would type in their PIN number. If you question whether or not a skimming device is attached to the machine, **use a different** ATM, gas pump, etc., and contact local law enforcement.

In addition to being able to recognize skimming devices, cardholders should also be leery of utilizing facilities that offer free Wi-Fi access for personal banking purposes or online shopping. Open Wi-Fi access offers hackers and credit card thieves a much easier avenue for stealing other users' personal information, even if the site has a lock or "https" in the URL.

Cardholders and consumers should use common sense when they receive e-mail messages or alerts that instruct the receiver to follow a link and enter personal information. Many times, these are phishing messages, which are fraudulent messages utilized for the sole purposes of stealing sensitive information, such as usernames, passwords, banking information, etc. When you are unsure about whether a message or e-mail is a phishing message, call the source directly (ex: if you receive an e-mail from your financial institution, call the bank directly) or close out all tabs and utilize the secure log-in from the appropriate website. Do not click on any attached links and enter in sensitive information!

Lastly, cardholders and consumers should be aware of their rights and responsibilities as a cardholder of the appropriate financial institution. Many companies offer fraud protection for little or no cost to the cardholder. Make sure you are utilizing all available benefits to ensure you are protected from credit card and/or identity theft.

Winter Break Theft Prevention

With the end of the semester quickly approaching, students living within residence halls should be aware of the upcoming winter break closure dates. The residence halls will close at 2:00 P.M. on Saturday, December 15, 2018, and will reopen at 9:00 A.M. on Saturday, January 12, 2019.

As many people know, with the majority of students returning to their hometowns during the winter break, thefts and burglaries tend to increase this time of year. Please remember to take all items you will need during break. Students will not be permitted back into the buildings during winter break. In addition, take your valuable possessions home with you. If you cannot pack your valuable items, make sure to have a list of your possessions and all relevant information (make, model, color, serial number, etc.) Housing and the Department of Public Safety have partnered up to create a web-based form for students to utilize when recording this pertinent information.

Lastly, in order to maintain the security of your remaining possessions, make sure all doors and windows are locked prior to leaving campus. This includes the connecting door between the resident's room and his or her restroom.

Reporting Crimes/ Incidents?

Option 1– Report to the University

When a report is made to the University, you have the option of addressing the incident under the University's policies and Student Conduct Code. The University will provide any available interim protective measures such as academic accommodations, changes to housing, and changes to class or work schedules. The University will initiate an investigation regardless of where the incident occurred. University reports can be made to any SIU Employee, any SIU Campus Security Authority, The Office of Equity and Compliance, Title IX Coordinator, or Student Rights and Responsibilities. Option 2- Report to Law Enforcement

Incidents on SIU Campus: If it's an emergency, call 911. For nonemergency incidents, call the SIU Department of Public Safety, 618-453-3771. Reporting crimes and emergencies to the Department of Public Safety will generate a law enforcement response and investigation. The Department will notify the necessary University staff of the incident. Incidents within Carbondale: If it's an emergency, call 911, for non-emergency incidents call the Carbondale Police Department, 618-457-3200. Reporting crimes and emergencies to the Carbondale Police will generate a law enforcement response and investigation. Carbondale Police works closely with the SIU Department of Public Safety and the University, with reports being forwarded to the necessary University staff of the incident.
